The District Educational Officer, Eluru District, Eluru has verified the application with reference to the Inspection Report of the Inspecting Officer and as per G.O.Ms.No.1 Education, Dated.01.01.1994 and recommended for opening of **VIII (EM) Class** for the academic year 2024-2025.


After careful examination of the proposals for Opening of Class **VIII** received from the Society and also the Inspection Report of the Inspecting Officer in the reference 6th read above, permission is hereby accorded purely on Temporary Basis for Opening of the following classes in **Bodhi Tree EM High School, D.No.18-4-233/1, Near Saibaba Statue, Eluru Road, Manikanta Grand Township, Jangareddy Gudem, Eluru District** under Rule 3(2) of G.O.Ms.No.1 Education, Dated.01.01.1994 subject to the following conditions.

1. That the society shall abide to the rules and regulations made in the Government order 1st to 3rd above.
2. That the society shall provide the necessary amenities like accommodation, Sanitary facilities, Drinking Water facilities, Furniture, Library, Laboratory Equipment, Play Field required staff as per the staff pattern and other facilities are necessary, before approaching the competent authority.
3. That the society shall apply for recognition by 31st August at the latest duly fulfilling the conditions.
4. That the permission accorded is restricted to this year only and it is not valid for subsequent academic year.

5. That this permission does not confer any right on the society for claiming recognition.
6. That the permission is accorded to **Makhish Educational Society, Jangareddy Gudem** and no other society or body can open a school on their behalf of.
7. The permission is accorded to open the school premises in the locality and there shall not be change in the premises or locality.
8. The society shall provide the necessary material even if it costs more than the deposit amount.
9. Following the NEP norms as per reference 4th read above.
10. Proper and adequate sanitation facility shall be provided for students especially for girl students.
11. Proper and adequate safety measures shall be taken for children within the school campus and also near the school premises.
12. The school shall follow the traffic and safety guidelines indicated by the police and fire services departments.
13. The parent Teachers Associations meeting shall be conducted to sensitize the parents on the safety of the children.
14. The school shall have first aid kit and the teachers shall be trained in first aid.
15. The management should fulfill all the conditions as per G.O.Ms.No.41 Education, Dated.11.5.2006 at the time of applying for Provisional Recognition.
16. The management is hereby informed that, the permission is being given purely on a temporary basis and is subject to the report of State Level Inspection and Vigilance Committee fulfilling of all the prerequisite conditions under A.P. Educational Act, 1982 and if later found that the school has not fulfilled any prerequisites as stipulated, the permission now being given is liable to be withdrawn at once.
